# 2025-2026 (FY26) Budget Highlights

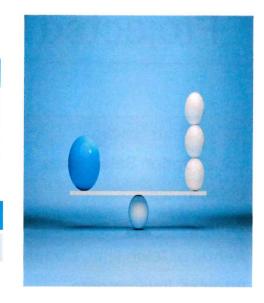
- Property Tax Rate to stay at .06¢
  - NO TAX INCREASE
- Conservative approach to budgeting responsible projections of revenues and expenses
- Sustained funding to the St. James Fire Department operations and current capital requests
- New projects include upgrading Town facilities, and an increase in community special activities
- Continued Savings toward future disaster recovery

Revenues for this proposed budget are \$251,000 higher than the prior year, without regard to the Grant Income. This increase is due to an increase in projected interest income, a 2% projected increase from Ad Valorem taxes, and an average of 13% increase from zoning fees, event center revenue, and other taxes.

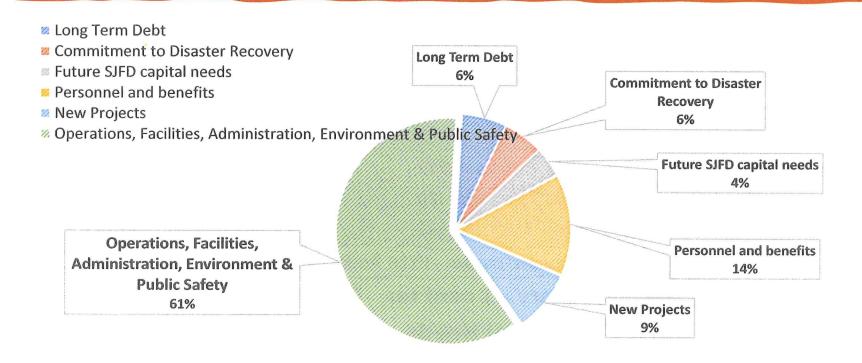
